1. Call to Order

5. Reports

Financial Report

Sarah Marques from Walke & Associates presented the budget and financial statements for the previous month.

- Sarah noted that wildland income payments from the state were delayed, with Chief Aaron Jonke explaining that the state's system changes, and a high volume of billing requests had slowed processing in 2024.
- Sarah also presented an initial draft of the 2025 budget, noting that it is in its preliminary stages. She will work with Chief Jonke to refine and finalize the budget.
- Sarah reported an expected loss of \$30,000 in the 2025 mill levy revenue.

Fire Chief's Report

Chief Aaron Jonke provided the following updates:

- **Staffing Concerns:** Three members are currently on long-term leave due to non-line-of-duty injuries, creating staffing challenges.
- **Driver/Operator Training:** Training and certification for Driver/Operator roles are scheduled for October.
- **Fleet Condition:** Concerns were reported from deployed firefighters regarding the condition of Brush 112. Chief Jonke recommended that the board consider replacing the unit and noted that apparatus prices have seen significant increases.
- **FRWRM Grant Application:** Chief Jonke outlined an application submitted for the FRWRM Grant, intended to support wildfire mitigation efforts in high-risk Wildland Urban Interface (WUI) areas. The grant would fund equipment, mitigation work, and a new Wildfire Division Chief position, jointly funded by the grant and SAFPD. This position would oversee mitigation efforts, community engagement, and coordination per the Chaffee County Community Wildfire Protection Plan (CWPP). The grant would promote collaboration with Colorado Firecamp and the City of Salida, aiming to adopt a "one community" approach to wildfire concerns.
- **New Fire Station:** Chief Jonke reported that the new firehouse is expected to open around the third week of December.

Wildland Coordinator's Report

Captain Bainbridge reported the following:

- **Weather and Fire Risk:** Precipitation has started in the mountains, but fuels such as grasses remain dry, and the fire danger is still high.
 - **Resource Deployment:** SAFPD personnel and assets are currently deployed across six states. In addition, SAFPD crews are involved in hurricane relief efforts.
 - **Operational Demand:** This season has seen high activity levels, with apparatus deployed throughout most of the year. The air tanker has returned to Colorado Springs and is now available for further deployments.
